- .2-The school will also abide itself by the conditions of affiliation already prescribed by the State Government concerned.
- As per Affiliation Bye-laws the optimum strength of a section should not exceed more than 40 9 students
- School should have at least one adequately equipped computer lab with a minimum of 10 10. computers and would ensure computer student ratio of 1.20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider
- 11. The section teacher ratio of 1.1.5 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.

appointment of the teachers on probation.
